All the District Educational Officers & Ex-officio P.C., SS and Additional Project Coordinators, SS except East Godavari, Dr. B. R. Ambedkar Konaseema, West Godavari, Krishna and Guntur in the State are informed that in the ref. 1st cited, Government has accorded permission for filling up of vacant teaching posts in all 352 KGBVs on contract basis for the academic year 2026 -27 with view to provide quality education to girl students studying in the KGBVs to make them as 21st century global citizens.
